With prayers that God may continue to bless you and those whom you serve, I remain

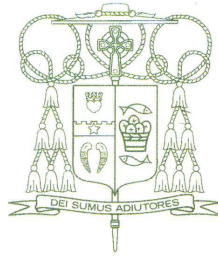

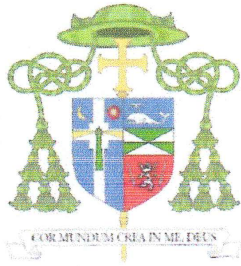

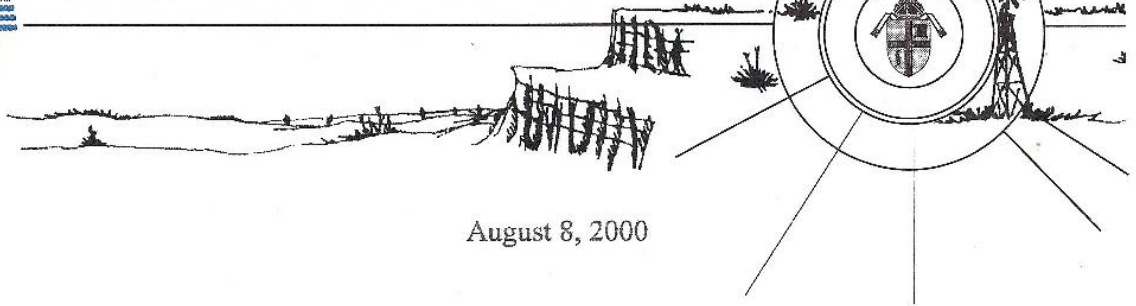
I recommend him for any parish who is looking for a healing mission. Thank you for your consideration in this ministry. May God bless you, let us keep each other in prayer.
